A copy of the SSSI Code of Ethics is included in the pack as well. Please read the Code carefully and sign and date the Acknowledgement Form. No application will be processed without this form. Also, included is an optional questionnaire regarding your experience with the ES P-AP certification process. Your experience will provide valuable feedback to the SSSI Engineering and Mining Surveying Commission Certification Panel.
