 and data bases of materials and publications relevant to the spatial sciences.

South East Asia Survey Congress, Darwin.

Built around the theme of *Communication, Collaboration and Capacity-building*, this event brought ASEAN and Australian surveying practioners together. In addition, the inaugural Youth Forum provided an opportunity for young professionals both in ASEAN countries and Australia to develop next generation collaboration.

Active and relevant events calendar.

Well over 100 learning and networking events were held for SSSI members and industry professionals all over Australia, creating opportunities for increased connection between professionals as well as gaining valuable continuing professional development. We have delivered to date 24 webinars, with a total of over 2700 participants, including the SSSI/ICSM Upgrades to the AGRS Series, which has had over 1700 viewers.

Asia-Pacific Spatial Excellence Awards (APSEA).

In 2019, APSEA dinners were held all over Australia and New Zealand announcing regional winners. This year, for the first time ever, the Oceanic APSEA ceremony will be held online. APSEALIVE will celebrate finalists and announce the Oceanic 2019 APSEA winners.

SSSI National Bushfire Recovery Map-a-thon.

In response to the devastating bushfires affecting many parts of Australia, the Map-a-thon was held on 9 February 2020. Over 600 national and international surveying and spatial science professionals mapped a total area of 2,793,879 hectares, with 15,731 edits, 13,891 building edits, 1,091 damaged features mapped, and 945 damaged buildings mapped. It is believed the SSSI National Bushfire Recovery Map-a-thon is one of the largest single mapping events ever held in Australasia.

Young Professionals Mentoring Program.

Championed by the SSSI YPs, the Mentoring Program facilitates connections between students and early career professionals with experienced practitioners in the surveying and spatial sciences industry. In its second year, just over 200 mentors and mentees graduated from the program.

Formation of new Special Interest Group - Disaster Management and Recovery.

From the SSSI National Bushfire Recovery Map-a-thon, there was a clear need for SSSI to form a group to coordinate volunteer surveying and spatial science activities when a natural disaster strikes (such as bushfires, floods etc), hence the Disaster Management and Recovery Special Interest Group was formed. The group's mission is to drive collaboration and information sharing in relation to surveying and spatial information citizens science initiatives.

ESP-AP Certification.

The Engineering and Mining Surveying Commission has reviewed and updated the ESP-AP procedures manual and application form. ESP-AP is formal national recognition that a person has the necessary knowledge and experience to competently perform engineering surveys and associated activities. It benefits an employee by providing recognition and career opportunities and an employer by increasing their credibility to customers.

MOU agreements.

Formalising our relationships with key organisations is critical in fostering a stronger collaboration of surveying and spatial professionals in our region and beyond, as well maintaining our sustained relevance and opening opportunities for improved learning and knowledge sharing.

Appointment of Tony Wheeler, Chief Executive Officer.

Appointed in May 2020, Tony has led the spatial industry in various forums in the past and has a track record of delivering successful outcomes for the Industry.

Our Future

Looking back on our achievements over the last 12 months, SSSI has a lot to be proud of. With strong leadership, a dedicated volunteer base and committed staff, SSSI is looking forward and focussing its energies on a number of new activities and initiatives, plus further strengthening its position as the peak surveying and spatial body in Australia. These achievements have set us on a pathway to a strong future.

Certification recognises that a person has demonstrated that he or she has the necessary knowledge and experience to competently work in their area of expertise. Over the next 12 months significant effort is being applied to standardise our certification nationally and ensure consistency across all commissions.
Spatially enabled Digital Twins can be designed to better plan, manage, and maintain resources in urban environments and are driving the need for better access to high quality 3D and 4D (temporal) spatial data to allow for advanced visualisation and analytics. SSSI is keen to be the leader in educating and developing capability within the surveying and spatial profession in this emerging technology. A Spatial Digital Twin Special Interest Group is currently under formation to ensure SSSI is leading the conversation in this area.
SSSI is a member of the working party for the 2030 Space and Spatial Roadmap and is on the Steering Committee. An opportunity now exists to coordinate the collaboration and develop synergies between the spatial and space industry sectors. SSSI will continue to be actively involved in the development of this important strategy and be part of the space and spatial conversation with great interest and optimism.
SSSI is proud to be part of the Space, Spatial and Surveying Diversity Leadership Network (SSS-DLN) which brings together senior leaders from business, government and education to provide visible advocacy for diversity and inclusion within the profession. Over the next 12 months. SSSI is active on the SSS-DLN Research Steering Committee and is playing a lead role in providing secretariat support. This committee has been formed to communicate to businesses and individuals the importance of diversity and inclusion and to determine the current status of diversity and inclusion in the sector.
For SSSI to be an inclusive body that represents the surveying and spatial sectors, we cannot do this in isolation. MoU's are critical in fostering stronger collaboration in our region and beyond, as well maintaining our sustained relevance and opening opportunities for improved learning and knowledge sharing. Over the next 12 months we will be strengthening our international reach.
For SSSI to be a progressive and relevant professional body, it is essential that our house is in order. Over the next few months, SSSI will undertake a full constitutional review and ensure it is effectively structured to deliver maximum benefits to members. This will be brought to members to consider in mid 2021.
All SSSI members renewing their membership for the 2020/21 financial year and new members joining have been offered access to SSSI organised webinars free of charge. The response has been extremely positive, with over 60 webinars delivered over the past four months. SSSI looks forward to strengthening our capacity to deliver more CPD and online learning opportunities in the future.



President's Report

SSSI is a strong, resilient organisation that is adaptable to change. These words have never been so true after the year we have all experienced. It is with great pleasure that I present the President's Report for the 2019/2020 financial year.

It is very satisfying to read our achievements as an Institute, which are listed at the beginning of this Annual Report. Our achievements are testament to our strong member base, dedicated volunteers and energetic staff. On behalf of the SSSI National Board, I thank every member, colleague and friend of SSSI who has contributed to the growth of this organisation. You are all part of our success.

The highlights during the year have been many. But I would first like to acknowledge Tony Wheeler, who was appointed Chief Executive Officer earlier this year. He has brought strength and focus to SSSI and I know under his leadership SSSI will prosper.

As President, I have focussed on extending SSSI's national and international reach. For SSSI to continue to provide value to members and effectively participate in the geospatial sector, we need to affiliate ourselves with other like-minded bodies and work collaboratively. Over the past 12



months, SSSI has signed MoUs with Open Geospatial Consortium (OGC), Association of Southeast Asian Nations Federation of Land Surveying and Geomatics (ASEAN FLAG) and Pacific Geospatial and Surveying Council (PGSC).

We are also progressing MoU's with Australasian Hydrographic Society (AHS), the Association for Geographic Information (AGI) UK, Earth Observation Australia (EOA) and Surveying and Spatial New Zealand (S+SNZ). To SSSI, these MOU's are more than just a signed piece of paper filed away. We are exchanging information, we are sharing knowledge, we are engaged and actively seeking opportunities that will benefit our members and the wider profession.

This past year, we have also gained government recognition. SSSI was invited to participate in a consultative workshop which provided input into the development of the ANZLIC Strategic Plan for 2020-24 and advocate the importance of capacity building for spatial professionals. It has also been an honour to represent SSSI on the steering committee of the 2030 Space and Spatial Industry Roadmap Road Map.

I was humbled earlier this year when our surveying and spatial profession came together in response to the bushfires that affected many parts of Australia. The SSSI National Bushfire Recovery Map-a-thon was held in early February where our profession mapped burnt infrastructure. Over 600 professionals participated from around 25 countries.

This work highlighted the important role of the geospatial community in times of disaster. As a result, the SSSI Disaster Management & Recovery Special Interest Group was formed and is Chaired by SSSI Board Director, Dr Lesley Arnold.

The SSSI Board has also approved the formation of the Spatial Digital Twin Special Interest Group with Wayne Patterson, SSSI Board Director appointed Chair. This SIG will focus on strengthening Jurisdictional conversation on Spatial Digital Twin and identify capacity building opportunities for SSSI Members. Spatial Digital Twin is also one of the key agendas of the ANZLIC Strategic Plan.

SSSI, through our Young Professional network co-ordinated a second and very successful YP Mentoring Program. A great opportunity for mentors and mentees to meet on a regular basis and share knowledge and ideas. The Mentoring Program continues to improve and provide much value to those at any stage of their careers. Thanks to the YP Committee Volunteers for their ongoing support to the institute. I also acknowledge their active support and participation in the Map-a-thon initiative.

This year, SSSI has been committed to delivering quality CPD to our members. Whether it be a large event like the South East Asian Surveying Congress or a bespoke webinar about drones, SSSI is always dedicated to ensuring our events meet members expectations (and of course CPD requirements). I have been impressed by the way our staff and members responded immediately for the need to transfer all our events online. I know many hours have been dedicated behind the scenes to make the delivery of online webinars and eConferences look like a seamless process.

Although this year's Locate has been rescheduled for next year Locate 21, SSSI has been active in participating in the Locate Connect online initiative spread across the year. As a shareholder pf Locate, SSSI continuously has been working to support both the management and delivery of Locate Conference Program through its nominated representatives.

As my tenure of President ends, it is with great satisfaction that I look back on SSSI's achievements. Reflecting on my short time as CEO of SSSI, I am proud to say our team has made great progress in improving our value to members and the overall geospatial community.



SSSI is well known as being the peak body representing the surveying and spatial sectors, we are also an 'inclusive' body. We work with other organisations that provide value to our members and allows them to access interesting and useful information, CPD programs, Certification and skills development opportunities. Collaboration brings many opportunities.

The opportunities for SSSI to closely collaborate with highly regarded international bodies such as FIG, ISPRS, OGC, ASEAN FLAG, AURISA, RICS UK, WGIC, ISDE, S+SNZ allows us to bring best practice knowledge to our members, offering a global network of knowledge that is unique to this industry.

SSSI is proud to be part of the Space, Spatial and Surveying Diversity Leadership Network (SSS-DLN). This is an industry wide Inclusivity and Diversity Network that aims to create an industry wide culture that thrives on mutual respect, teamwork and diversity of thought in the workplace, a culture that is inclusive for everyone. We look forward to fostering a profession which is diverse and inclusive. SSSI is also active on the SSS-DLN Research Steering Committee and is proud to provide secretariat support.

For SSSI to retain its reputation as a learned organisation, we need to make sure we are moving quickly, so that we can equip our members in the best way possible to be able to harness and exploit the rapidly advancing technologies. These technologies include SBAS, drones, IoT, AI and automation applied to image analysis, along with rapid point cloud processing for terrestrial and airborne LIDAR. Our industry is already applying these technologies to practical solutions such as spatial digital twin databases, smart agriculture, emergency management, along with various major infrastructure, mining and environmental projects. We want SSSI members to be able to develop their skills so that they can apply these technologies with more intelligence and sophistication than was possible yesterday and achieve more meaningful outcomes.

The board of SSSI has recently approved the formation of the Spatial Digital Twin Special Interest Group, led by SSSI Director Wayne Patterson who also leads the team producing the Western Sydney Precinct Spatial Digital Twin that created 3D and 4D digital representation of buildings, strata plans, trees and roads throughout eight local government areas across Western Sydney comprising the Western Parkland City, Greater Parramatta and the Western Peninsula.

I would also like to acknowledge the formation of the Disaster Management & Recovery Special Interest Group led by SSSI Director, Dr Lesley Arnold. Though this group was formed only a month ago, it has had much success with the SSSI Bushfire Recovery Map-a-thon.

As we strive to take a lead role in so many emerging technologies and capabilities, more SSSI Special Interest Groups will emerge in coming months.


Certification of specific skills is an area that is currently under-recognised by employers and under-utilised by members. Certification of the various strands of surveying and spatial sciences to nationally agreed standards that are reviewed annually will not only raise the skill standard of the profession it will have the flow on effect of better outcomes for the organisations engaging those staff who will in turn provide better outcomes for their clients. We are now working towards the creation of national registers for each discipline and standardising our approach to certification across of our all Commissions.

Spatial Sciences is classified as an emerging industry and has enjoyed steady growth over the past two decades. The industry is now growing and diversifying, but it is widely acknowledged that we are facing a skills shortage. The profession has a low profile in the general community. Surveying and Spatial Sciences have so much to offer as a career but attracting school leavers to enter our profession remains challenging despite some recent great initiatives. We will aim to be a more active voice of the surveying and spatial profession to ensure we attract students to these disciplines and influence policy at all levels of government.

I would like to acknowledge Peter Olah, the previous SSSI CEO for his hard work, and Anna Palathinkal who was a dedicated and hard working COO, and of course the fantastic team we have on staff now that work so hard to meet member's requirements.

Over the past few months, SSSI has worked hard to improve its governance framework and strategic direction. We need to be adaptable as we become a stronger organisation which continues to meet our members need. But there is more to be done here and a review of our constitution is underway to ensure we are well placed to adapt to the future.

Finally I would like to acknowledge the outgoing Board for their passion and commitment to SSSI led by retiring President Dr Zaffar Sadiq Mohamed-Ghouse FRGS FSSSI FIEAust who has worked tirelessly to ensure SSSI remains active and relevant to the geospatial community



Commission Reports

7.1 Engineering & Mining Surveying

The focus for the Engineering & Mining Surveying Commission over the past 12 months has been updating the Engineering Surveying Profession (Australasia Pacific) (ESP-AP) Certification Procedures Manual and Application form. It is now a simpler process for engineering surveying professionals to become certified.

Certification is invaluable to individuals as they move through all stages of their careers. It is a formal recognition that an individual is an expert in their field and keeps up to date with current technologies and the direction of the industry. Certification can also present a competitive edge and provide new opportunities to take individuals further in their career journey.

Certification is also beneficial for employers and businesses, helping them to provide clients with assurance that the work they carry out will be to high industry standards and will cement their position as trusted advisors.

There are three clear	pathways for Engineering Surveyors to gain ESP-AP Certification:
Emeritus Provision	Emeritus achievement of ES P-AP is available to those SSSI members and non-members who have retired as an ES P-AP and wish to maintain the recognition of their professional standing in retirement. Emeritus ES P-AP is an honorary recognition and as such does not require an annual CPD return to maintain certification.
Qualification Based Provision	Require AQF/NZQF Level 7 surveying related qualification and a minimum of 4 years of documented work experience. Or (at minimum) AQF/NZQF Level 6 certification and further education (to be gained either from a Non-Survey Diploma/Degree or alternatively through Course Points, Short courses and workshops, and Seminars and Conferences together) along with a minimum of 4 years of documented work experience.
Long Term Practice Provision	This option requires a minimum of an Australian AQF or NZQF Level 6 surveying related qualification or AQF/NZQF Level 5 surveying related qualification (obtained during or before 2015) along with 10 years' documented work experience while also obtaining a minimum of 300 documented points within the Professional Experience component for ESP-AP. Please note - this provision is only available until the 1st of July, 2023.

The next focus is to promote the certification to the profession and employers. Our ultimate aim is to have ESP-AP as a requirement within government specification for all contracts. There is much work to do and it is pleasing to see that certification will be a priority area for SSSI champion over the next 12 months.

On behalf of the EMSC, I would like to thank the ESP-AP Panel for their assistance in ensuring our profession remains certified. Also, thank you to all the members of the EMSC for your commitment and contributions over the past 12 months.



I would also like to acknowledge the members of the EMSC National Committee who have tirelessly worked over the past 12 months in reviewing the ESP-AP Manual and advocating the importance of certification.

7.2 Hydrography

The last half of the 19/20 year has been disrupted by the COVID 19 pandemic and this has resulted in the cancellation of all face-to-face meetings and has restricted travel. Members of the Hydrography Commission generally undertake large amounts of domestic and international travel to carry out their work activities, resulting in 2020 being very challenging for many.

I would like to acknowledge the work of members of the Hydrography

Commission National Committee (HCNC). We are all volunteers and the HCNC members have undertaken a considerable amount of work on behalf of the Commission, the Institute and the wider hydrographic community in Australia, New Zealand and internationally.

I would also like to thank the Australasian Hydrographic Surveyors Certification Panel (AHSCP) for their hard work this year. The AHSCP is the certification arm of the Commission and one of the SSSI's four specialist certification bodies. It is internationally recognised by the FIG/IHO/ICA International Board for Standards of Competence (IBSC) as a regional certifier of hydrographic surveyor competence and is jointly sponsored by SSSI and Survey+Spatial New Zealand).

The panel has seen a significant increase in the number of applicants for certification, a portion of this increase can be attributed to the introduction of the Hydroscheme Industry Participation Program (HIPP) in addition to greater awareness of the scheme internationally.

HCNC Committee

Despite the disruption of the first half of 2020, the HCNC continued to meet via Zoom and continue working on behalf of members. As the Chair mentioned in last year's report, most of our activities have long timeframe so, when the Commission reports on an outcome, it may be the result of several year's work with many hours of volunteer time expended. The HCNC met four times throughout the year to discuss the ongoing action items and a meeting was also held to discuss what support the HCNC could do to support members during the pandemic.

A summary of the activities and initiatives undertaken this year includes:

- Wollongong TAFE is now offering the Diploma of Hydrographic Surveying on its syllabus. This
 was the result of negotiation by the HCNC and TAFE; a lot of work undertaken by Richard
 Cullen to make this happen.
- Ongoing engagement with the Australian Bureau of Statistics (ABS) on the re-definition of 311415 Hydrographer in ANZSCO and ANZSIC
- Ongoing review of *Surveying Award MA000066* to introduce and reflect the work environment of the hydrographic surveyor
- The Commission's mentoring programme in conjunction with the SSSI YP National Mentoring Program is close to release.
- The audit sub-committee overseeing CPD compliance, is able to access members CPD records to enable better assessment of CPD requirements.
- The Committee agreed to pro rata CPD points for 19/20 to 10 due to the pandemic, which resulted in many CPD events to be cancelled.
- A virtual World Hydrography Day event was held on June 21 that attracted a good number of participants.
- A Memorandum of Understanding (MOU) was signed between the SSSI HC and the Australasian Hydrographic Society (AHS), allowing greater collaboration between the two organisations.
- The Hydrographic Excellence award was awarded to iXblue for the use of Autonomous technology.
- NZQA Certificate was mapped against the IHO Syllabus to assess suitability as a recognised qualification for certification.
- Work has begun on a list of students interested in potential work experience in the field
 of hydrography to be posted on the web site. This will be a collaboration between the
 commission, educational institutions, and industry.

AHSCP Activities

The Panel met three times during the period to assess applications via tele-conferences; the usual face to face was cancelled due to the pandemic. The meeting schedule was as follows:

- 85th AHSCP Meeting held on 04 October 2019
- 86th AHSCP Meeting held on 12 December 2019
- 87th AHSCP Meeting held on 13 March 2020

The Panel assessed a total of 17 applicants during the year, as follows:

- 10 individuals were assessed for Level 1, of which 2 was awarded certification, 7 applications were deferred with the applicants required to furnish additional information and 1 applicant was unsuccessful.
- 7 individuals were assessed for Level 2, of which 5 were awarded certification and 2 applications were deferred with the applicants required to furnish additional information.

In 2012 the IBSC¹ recognised the AHSCP Certification Scheme as a regional scheme for individual recognition. The recognition is valid for a period of 6 years, and re-recognition is subject to a successful application submitted at the end of this period.

The AHSCP's submission for continued recognition of its certification scheme was considered by the IBSC at its annual meeting in 2019. The Board awarded certificate of recognition (to the AHSCP Certification Scheme) for a further period of 6 years, i.e. up to 2024.

A major revision of the AHSCP Guidelines and supporting documentation was undertaken as part of the IBSC re-recognition process. These were published as version 2.4 dated 29 Feb 2020 and are now in effect. The revised documents fully reflect the adoption of the IHO S-5A and S-5B standards, and contain transition arrangements for those who have commenced logbooks and are seeking certification under the older S-5 11th Edition standards

During the year, Mr. Neil Hewitt presented on the AHSCP Certification Scheme at the following international events:

- KL GeoHydro 2019 Conference, Kuala Lumpur, Malaysia in November 2019
- The IHO South West Pacific Hydrographic Commission (SWPHC) Conference held in Wollongong on 12-14 February 2020.

The AHSCP also signed a Mutual Recognition Agreement (MRA) with the Canadian Hydrographer Certification Program (CHCP), the only other IBSC recognised program. The MRA allows a certified hydrographic surveyor under either scheme to be certified under the other after a small amount of due diligence.

Nominations for two positions on the AHSCP were called in August 2019. A total of 2 nominations were received, i.e. one for each position. Therefore, Barry Smith and Neil Hewitt were elected as the 'Hydrography for Coastal Zone Management' and 'Private Practice' representatives respectively for a term of 2 years.

Sustaining Partners

I would like to express my gratitude to our Commission Sustaining Partners for their invaluable assistance to the Commission again this year: Precision Hydrographic Services, Hydrographic and Cadastral Survey, BlueZone Group, iXblue, Queensland Government Department of Environment and Science, Australian Hydrographic Office, TeledyneCaris and Fugro.

7.3 Land Surveying

In this year of re-adjustment, the National Land Surveying Commission (NLSC) met every two months and will endeavour to hold a face to face meeting at Locate when possible. We have representatives from all Regions on the National committee.

The NLSC has chosen to concentrate on four key agenda items:

- 1. National Certification
- 2. Measures to assist candidates undertaking Professional Training Agreements to obtain their Licensing/Registration more promptly.
- 3. A national approach to CPD particularly regarding Cadastral matters
- 4. National harmonisation of standards which relate to Surveying



Advocacy

Several national submissions have been made in the past year including:

- Infrastructure Australia Audit
 - As part of its 2019 Audit, Infrastructure Australia identified several issues, gaps and problems to develop a clear understanding of the challenges and opportunities listed in its Audit. Infrastructure Australia subsequently requested feedback and the National Land Surveying Commission responded with a submission based on the role of surveyors, the importance to address our inherent skill shortages and the impact it could have on the delivery of infrastructure projects.
- Review of VET Qualifications in Surveying and Spatial Information Services
 As part of a national review of the units of competency in Surveying and Spatial Information
 Qualifications, an initial report recommended removal of the Advanced Diploma and some
 Cert 11 and Cert 111 courses. As a result of responses from industry and the TAFE sector,
 these recommendations were reversed. The retaining of the Advanced Diploma is especially
 important in WA as an important pathway for mine surveyor authorisation and certification
 and in Victoria, it is a successful pathway in encouraging students to articulate through to the
 Degree course.
- Draft National Registration Framework (NRF) for Building Practitioners
 A submission was made to the Draft National Registration Framework (NRF) for Building
 Practitioners. Although surveyors are not recognised as Building Practitioners in this framework,
 we emphasised the important underlying role we have in supporting the building industry
 activities and collaborating with Building Practitioners. We emphasised our already proven CPD
 training programs under existing legislation requirements as well as our certification programs
 and more recognition of these programs for surveyors involved in building industry activities.

National Certification

With the surveying profession partially regulated through state cadastral requirements it has been a little more complex to introduce a land surveying certification scheme.

Certification is a globally recognised system that provides encouragement of long-term professional development to ensure additional core competencies in surveying methods and technologies. The South Australian Government is now requiring specialist certification in land development assessment and a similar concept has been flagged in Victoria. Certification is not an alternative to Licensing/Registration, but will complement it. The Land Surveying Commission will be liaising with CRSBANZ and the respective surveyor boards on this matter.

Promotion of the Profession to Students

With SSSI being a member entity in both organisations, we have been able to combine the marketing material from the Surveying Task Force and Destination Spatial Qld to develop a presentation for schools. We also addressed participants at the Australian Orienteering Championships on the Surveying and Geospatial opportunities for students.

Surveying confirmed as Permitted Essential Work

This year has been one of the most challenging in testing the resilience of our members. Under COVID-19 Restrictions, surveying was recognised as Permitted Work. Even under the Stage 4 Restrictions that were applied in Victoria, surveyors were still able to operate under a COVID-19 Safety Plan. Should there be a relapse into stricter COVID-19 Restrictions at any time, there are many lessons learnt which can be passed on.

National Collaborative Forum

The NLSC has continued to participate in and support the continuation of a National Surveyors Discussion Forum with the other professional surveying bodies, ISNSW, ISV and S&SNZ, recognising SSSI as the National Professional Body. Some of the matters of mutual interest currently under discussion including maintenance of survey infrastructure, rationalisation of common standards between states and looking at a national approach to cadastral matters, align with those already being undertaken by SSSI.

· International Federation of Surveyors (F.I.G)

Australia currently has representatives chairing two FIG Commissions. Assoc Professor David Mitchell is Chair of Commission 2 - Professional Education and Daniel Paez is Chair of Commission 7 - Cadastre and Land Management. Rob Sarib also Chairs the FIG Asia/Pacific Capacity Development Network. We also have a number of participants in the working groups in each of the ten FIG Commissions and have started highlighting some of these FIG activities as Position Magazine articles.

Finally, congratulations to NLSC Committee member Michael Nietschke who was a joint winner of the Educational Development Award at the 2019 APSEA Awards.

As we slowly move into economic recovery, the NLSC will continue to maintain an active role in SSSI and the Commission will continue to act as the peak representative body regionally, nationally and internationally for Surveyors.

7.4 Remote Sensing and Photogrammetry

This National Remote Sensing & Photogrammetry Commission (NRSPC) is devoted to the development and promotion of remote sensing and photogrammetry professionalism and applications in Australia. The main objectives are:

- To work towards the continued recognition of the RS&P commission for excellence in professional development and representation of the Australian remote sensing and photogrammetry community.
- To provide the remote sensing and photogrammetry community with relevant professional development and representation
- To represent Australia in the International Remote Sensing and Photogrammetry Communities. In particular, to manage relationships with and contributing to *The International Society for Photogrammetry and Remote Sensing (ISPRS)* and the *Asian Association on Remote Sensing (AARS) Activities and Initiatives*

The RS&P Commission is proud to have supported the South East Asian Surveying Conference (SEASC) in Darwin in August 2019. A sub-committee of the SSSI NRSPC reviewed all abstracts submitted in the field of RSP to the SEASC Darwin conference, and handed out two awards during the conference dinner. The categories of the awards were Best Research Abstract and Best Industry Abstract.

The winner of the Best Research Abstract was Muhammad Hifney Haji Abd Rahman Darussalam from Brunei for his submission titled "The potential of using satellite altimetry for sea level study in Brunei Darussalam". The Best Industry Abstract went to Paul Digney from Australia for his abstract titled "The Sydney Harbour Bridge High Precision Terrestrial Laser Scanning Survey and 3D CADD Modelling".

The 40th Asian Conference on Remote Sensing was held in Daejeon from the 14 - 18 October 2019. The theme of the conference was "Progress of Remote Sensing Technology for a Smart Future". The conference was organized by the Korean Society for Remote Sensing and the Asian Association on Remote Sensing. The conference was sponsored by the Korea Aerospace Research Institute. This was the third time that Korea has hosted the conference. Dr Bruce Forster, the Honorary Secretary of the SSSI Commission on Remote Sensing and Photogrammetry, attended the conference and was the Australian delegate to the annual meetings of the Asian Association on Remote Sensing. Australia is the only non-Asian country who is a full member of the AARS. Dr Forster is also on the International Committee of the conference and on the Advisory Committee to the General Secretary, Professor Kohei Cho of Japan.

During this year's national APSEA awards long standing members of RSP Commission were recognised for their ongoing contributions to SSSI and RSP. Dipak Paudyal and Peter Kinne became SSSI Fellows and Chris Bellman was conferred Honorary Fellow.

The Body of Knowledge webpage is online. This webpage is a data repository and collaborative workspace for members and the broader industry providing links to publications, journals, conference proceedings and conference reports by members, online courses, free data, software and libraries.

SSSI is pleased to announce a cooperation with the American Society of Photogrammetry and Remote Sensing (ASPRS) which will bring several benefits for SSSI members. SSSI members were able to attend this year's ASPRS annual conference in June 2020 at the same cost for ASPRS members. Furthermore, SSSI members can attend ASPRS webinars for a reduced rate of only \$15.

The NRSPC is in the process of arranging similar cooperation with the German Society of Photogrammetry and Remote Sensing (DGPF), and offer SSSI webinars to members of the Pacific GIS and Remote Sensing Council (PGRSC) for a reduced rate.

Last November, 100 women from around the globe participated in a journey to Antarctica as part of Homeward Bound, the prestigious global leadership program for women in STEM. The program focuses on strategic capabilities, visibility, communication, science and technology in relation to the sustainable stewardship of our planet. Among the 2019 group heading to Antarctica there were three SSSI members, Raelene Forbes, Charity Mundava and Rebecca Handcock. Charity Mundava as a member of the national RSPC received support from the Commission and has presented on her experiences in a number of webinars.

- web map of our members to showcase our members spatially
- Contributed to Geomessage and Position Magazine including member profiles, event reviews and general SICC related matters.



With our members spread across the country, a members map has been created to provide a spatial awareness of our members and is a valuable resource in understanding our member base and will help with future planning of national events. The map is available on the SICC webpage.

 - d. Engaging with tertiary educational institutions

SSSI Young Professionals White Papers - Locate19 and SEASC2019

In April 2019 at Locate19, the inaugural Young Professionals Symposium was held, providing a forum to explore these questions and give young professionals, and young-at-heart professionals, a voice about these matters. The key findings from the SEASC2019 Young Professionals Day were:


- 1. Our YPs are the future of our industry, but also the now young at heart professionals need to start succession planning with the YPs in mind to help continue their legacies, and most importantly need to start giving YPS opportunities to develop their skills and experience with this in mind.
- 2. The culture of surveying urgently needs to adapt to embrace change, or another industry will fill the niche that rapid technological advances and AI creates we will be left behind. Career pathway visibility and embracing soft skills is vital and urgent at all levels of the workforce.
- 3. Career pathway visibility is an immense gap that we can relatively easily address. It is needed to get more people to stay in our industry, not only to get more people into our industry, both urgent matters globally.
- 4. YPs are urgently seeking leadership over management, and demographically have different needs. As an industry, businesses need to adapt to embrace this flexible work, diversity and inclusion, career pathway visibility, mentoring and coaching, etc.

8.2 Disaster Management & Recovery

The Disaster Management and Recovery Special Interest Group has been established to contribute surveying and spatial expertise, within a coordinated volunteer framework, to support preparedness, response and recovery efforts, nationally.

The catastrophic bushfires which caused devastation to many parts of Australia earlier this year affected all Australians. Those in the surveying and spatial profession were keen to provide assistance in some way. This resulted in the co-ordination of the SSSI National Bushfire Recovery Map-a-thon, where over 600 surveying and spatial professionals worked together to map burnt infrastructures in seven different project areas affected by bushfires.

From this mapathon, there was a clear need for SSSI to form a Special Interest Group to coordinate volunteer surveying and spatial science activities when a natural disaster strikes (such as bushfires, floods etc), hence the Disaster Management and Recovery Special Interest Group (DMR-SIG) was formed. It is a great honour to be appointed as the inaugural Chair.

The DMR-SIG will provide strategic direction and endorse SSSI volunteer activities that relate to collecting, validating, verifying and sharing surveying and spatial information required for disaster preparedness and recovery efforts. The SIG-DMR mission is to drive collaboration and information sharing in relation to surveying and spatial information citizens science initiatives. It will:

- Build a well-coordinated national network of surveying and spatial professional volunteers (organisations and individuals) able to respond to immediate disaster recovery needs.
- Provide leadership and coordination for volunteer surveying and spatial information activities.
- Develop a strategy and establish a framework that will stimulate and coordinate volunteer surveying and mapping disaster recovery efforts in the event of future disasters.
- Adopt policies and standards for volunteer data collection that are interoperable with the needs of government and academia.
- Consult with government and academia to determine data needs and priorities on all
 collaborative projects. The DMR-SIG comprises representatives from SSSI, state and
 commonwealth government, NGO's, open source community, academia and businesses. SSSI is
 appreciative of the participation and support that these organisations and the wider profession
 have provided in establishing this important group.

One of the key actions of the DMR-SIG, is to develop the volunteer framework that will be used to co-ordinate volunteer surveying and spatial efforts for disaster preparedness, response and recovery. This framework will be established in consultation with the DMR-SIG members and other key stakeholder groups. Partnerships with likeminded organisations will be a key success factor.

As work on the framework progresses, the DMR-SIG has organised and held the **SSSI National Bushfire Recovery Map-a-thon** which was held on Sunday, 9th February, 2020. The Map-a-thon was a way for the national and international community to join forces - achieving a total of 2,793,879 hectares of burnt area mapped. Over 600 individuals and teams registered to participate in the Map-a-thon from all over the world (representing over 25 countries). This is considered one of the largest single event map-a-thon held in the Australasian Region.

This significant achievement is due to the huge effort by surveying and spatial sciences volunteers globally, who participated on the day, and also because of the behind the scene efforts from the DMR-committee, SSSI YPs and other dedicated people. Importantly, the day would not have been possible without the financial and in-kind support of all our sponsors.

The DMR-SIG committee will be running future mapathon events – where we will be focussing on disaster preparedness mapping in readiness for the next bushfire season.

Events and Initiatives

In 2019 SSSI NSW prioritised its planning and coordination of a webinar program to reach the broader geographies and availabilities of our membership. Little did we know how perfect the timing of these plans would be with the onset of a pandemic early in 2020. Dr Daniel Paez was one of the opening keynote speakers who gave an update on the role of surveying and the International Federation of Surveyors (FIG). We also had a wonderful welcome to the Goulburn region receiving a Surveyors Perspective and Contribution on the City's History & Development from Justin Kell. The following two days had parallel Surveying and Geospatial Sessions as well as a fabulous dinner and Awards night for the Asia Pacific Excellence Awards.

NSW SSSI Celebrated World GIS Day with Don Murray at a breakfast event (hosted by 1Spatial & SSSI) on his first ever visit to Australia to speak on data integration and future directions for FME. As the Founder of SAFE Software this was a fantastic event to share with members and the broader industry.



Engagement

SMIC - Survey and Mapping Industry Council of NSW

SSSI NSW and SMIC have had an ongoing relationship that was fostered back in SMIC's inception in 1987 and SSSI NSW continues to renew its membership in SMIC. Liz and Mary-Ellen took turns as Chair and Deputy-Chair of the Spatial information Committee 2017-2020, Mary-Ellen sat on the Finance Committee 2018-2020 and the Land Boundary Definition Committee 2018-2019, also supporting the Discipline Committee 2019-2020, while Liz sat on the Training Committee 2018-2020. During their tenure Mary-Ellen and Liz took part in a governance review, an audit of assessments, delivered and coordinated spatial and technology presentations to the Board, regularly delivered training to Survey candidates at Kurri Kurri, as well as presentations to Survey Seminars and Conferences. We thank them for their time on the Board and are pleased to confirm SSSI was successful in securing another two representatives in Roshni Sharma (Deputy-Chair NSW SSSI) and Venessa O'Connell (NSW Port Authority) whose roles on BOSSI commenced at the end of June 2020. Roshni and Venessa have both joined the Spatial Information Committee and Roshni has taken a role on the CPD Committee.

Institution of Surveyors NSW

SSSI NSW has been supporting the Hunter Manning Group September Seminar for a number of years and did so again in 2019 with Mary-Ellen Feeney (Chair NSW) delivering a presentation on Surveying and Spatial in the consulting sector and her participation in Homeward Bound 2018-2019. While a few other ISNSW collaborations were planned for 2020 many of these were paused due to the pandemic but will resume 2021.

Orienteering Australia

Special thanks to Raelene Forbes who attended the Presentation Dinner for the 2019 Australian Schools' Orienteering Championships in Wagga Wagga. SSSI is pleased to continue our support for the Championships and help promote surveying and spatial concepts to the next generation.

Homeward Bound - STEMM

Over the last three years SSSI NSW has had a distinguished list of participants in the Homeward Bound Global Women in STEMM Leadership Program. The program is a ten-year program aimed to build a global network of 1000 women in STEMM (Science, Technology, Engineering, Mathematics, Medicine) and capacity build the skills women need as leaders. The program develops skills in strategy, visibility, communications, presentation, collaboration and group work, while facilitating key research projects both within and across cohorts. Currently five SSSI members have won scholarships for the highly competitive Homeward Bound Program. Mary-Ellen Feeney (SSSI NSW Chair) participated in 2018 spending January 2019 in Antarctica and delivering over 45 presentations to the community, schools and SSSI events, raising the profile of our profession and SSSI. In 2019 we saw NSW SSSI members Raelene Forbes (Snowy Hydro) and Charity Mundava (Water NSW) participate alongside WA SSSI member Rebecca Handcock (Curtin University) and share their experiences with SSSI Audiences through a number of webinars, as well as supporting contributions to a #TeamHB4 StoryMap and web application about their journey to Antarctica in November 2019. Roshni Sharma (Deputy-Chair NSW SSSI) has been chosen for the 5th cohort and the 2020 leadership program. While Roshni's journey to Antarctica has been delayed due to the pandemic, Roshni has made extraordinary contributions to the program and our engagement in the STEMM community through development of a podcast series called the Discomfort Zone as well as participation in an HB UN-Conference. We wish Roshni the best of luck for 2021!

Tertiary Sector

SSSI NSW has commenced a program of proactive engagement in the Education Sector. We have set up a twice-yearly meeting of representatives from NSW Universities and TAFE to plan activities and exchange of knowledge about interfaces for the academic and research sectors with industry and the professions. We have invited student representation in our conferences and events, contributions to our monthly Geomessage Newsletters as well as encouraged nominations for the regional Asia Pacific Spatial Excellence Awards. SSSI NSW has been involved in the planning of the Climate Change and Disaster Management Conference to be held at the University of NSW late 2020 and was proud to participate in the 2019 Launch and Graduation Ceremonies of the SSSI Mentor program in NSW at University of NSW and Macquarie University respectively.


The future

SSSI NSW & WA regions are holding a joint annual 2020 regional conference as an Online Seminar on Monday 30 November 2020. The theme is geospatial data and applications for climate change and disaster management (CCDM). The event is being held as part of a broader five day conference series on *Climate Change and Disaster Management: Technology and Resilience in a Troubled World* (30 November - 4 December 2020) as part of the ISPRS Geospatial Information for Disaster Management (Gi4DM) Annual Conference and the biannual Urban Resilience Asia Pacific (URAP) Conference. Join for other days such as Tutorial Tuesday or see academic research on related subjects Wednesday through Friday.

NSW Regional Asia Pacific Excellence Awards (APSEAs) are planned for Thursday 4 February as an online event. We plan to highlight brief descriptions of each of the nominees in a category, running a people's choice poll for the event, and then announcing winners. We are looking for a celebrity/guest speaker to do a bit of an introduction and give the event a fun and engaging atmosphere despite being online. We are thrilled to have 17 applications for awards and see the digital engagement of the celebration as a plus given the spread of our stakeholders and members across the state.

March is the month we celebrate Global Surveying Day so we plan to make it a surveying-themed month with an International Women's Day event planned for 4 March with an emphasis on *Women in Surveying* and Surveying Seminars both mid-March and mid-June to support cadastral and survey-practice professional development.

The NSW CPD Committee has been working to establish a network of CPD reviewers for not only SSSI but also BOSSI CPD points. As one of BOSSI's Ratified organisations for CPD point allocation SSSI will be reviewing our CPD processes and implementing them in consultation with BOSSI for the 2020-2021 CPD assessment year. We look forward to reporting on the progress in this space for the next annual report.



9.3 Queensland

SSSI Queensland was proud to once again have achieved a high retention of our existing members and increased our membership through re-admissions and new members throughout the 2019-20 year. Events

The recent fiscal year saw continued delivery of workshops, meetings and events.

Some Queensland members attended and participated in the successful SEASC conference held in Darwin in August 2019. Queensland Surveying and Spatial Day

The second half of the financial year was a very different story with the rising concern of COVID-19. As the current Convenor for the Locate Conference, I was busy with the Locate Team making final preparations for the then upcoming Locate20 Conference in Brisbane and we had completed a successful cadastral seminar in Brisbane before the situation changed dramatically. National restrictions on travel and business operations caused the association to re-evaluate its operations.

In our activity in the 19-20 year, we actively implemented the following initiatives:


- Held dedicated face to face seminars and facilitated collective feedback to Department of Natural Resources, Mines and Energy (DNRME) to facilitate enhancements of the Cadastral Surveying Requirements review currently being undertaken by DNRME.
- Furthered the protection of survey marks initiatives to include recognition by Local Government Association of Queensland (LGAQ) in advising all local government members of the importance of this initiative.
- Planned a dedicated webinar series for late 2020 to support post graduate training of surveyors in the areas of Global Navigation Satellite System (GNSS) for surveyors, reinstating and marking boundaries, searching documentary evidence, law relating to Cadastral surveying, preparing and managing basic development applications, geodetic reference system applications and calculating volumes and quantities.

In addition to these dedicated activities, our committee volunteers have also actively participated in wider industry collaboration with the DNRME Surveying Focus Group, Destination Spatial and 3D QLD taskforce.

The future

Sadly, Locate 20 event was postponed along with any face to face events in 2020. However, the Queensland region is looking forward to the new version of Locate. Locate 21 will see the introduction of a hybrid model - a combination of virtual events with live in person gatherings at various locations including the central Brisbane live site. I would like to encourage all our Queensland members to join us in attending this COVID-safe event. 
We are already starting to organize the return to face-to-face events and have an exciting line-up planned for 2021.

Our Activities and Initiatives

10.1 YP Mentoring Program

In its second year, the YP mentoring program continues to grow from strength to strength. On a fortnightly basis, mentors and mentees met to discuss given topics exploring a range of facets from career goal setting, leadership and emotional intelligence, networking, and more.

The program runs in two streams: (a) undergraduate, for current students or recent graduates, and (b) graduate, for young professionals who are in the workforce and looking to step up their careers.

Over 200 mentors and mentees participated in the 2019 YP Mentoring Program with participants finding the program to be engaging, interesting and very valuable.

Many thanks to CR Kennedy for sponsoring the YP Mentoring Program in 2019.

10.2 SSSI National Bushfire Recovery Map-a-thon

During late 2019 and early 2020 major bushfires have heavily impacted regions of New South Wales, eastern and north-eastern Victoria, Canberra and Kangaroo Island in South Australia, and large areas of forest have been burnt. During this time over 18.6 million hectares of land was burnt, 34 people killed and an estimated one billion animals killed, with some endangered species possibly driven to extinction.

As the fires reach their peak late December 2019, SSSI was inundated will calls from our surveying and spatial sciences community, asking what they could do to help their fellow Australians. Calls came from individuals and companies offering support.

SSSI consulted with Commonwealth and State Government agencies, the newly formed National Bushfire Recovery Agency (NBRA), industry peak bodies and NGOs, seeking advice on how our profession could contribute. This consultation led to the SSSI National Bushfire Recovery Map-athon held on Sunday, 9th February 2020, and the location of burnt infrastructure being the main priority.

The map-a-thon was held at six locations across Australia, with venues provided by GHD and Aurecon, and refreshments generously supported by Veris, Leica, Hexagon Geospatial, Jacobs and Hydro Tasmania.





There were over 600 registered participants - 300 joined remotely from home and 44 teams took part from other locations, in addition to the organised venues. There were 100 overseas participants from 26 countries - Albania, Belgium, Bolivia, Bulgaria, Canada, China, Commonwealth of the Northern Mariana Islands, Fiji Islands, Germany, Ghana, Guam, Hong Kong, India, Italy, Jamaica, Kenya, Nepal, New Zealand, Nigeria, Philippines, Qatar, Spain, Sri Lanka, Tanzania, USA, and Zimbabwe.

Participants were fortunate to have had access to hundreds of thousands of dollars' worth of aerial imagery on the day, and SSSI is grateful to supporters Nearmap, Planet and Airbus for pledging support and working overtime to ensure the imagery was available on the day. This post-fire imagery was crucial to the success of the map-a-thon as it was used to detect damaged and destroyed infrastructure. Satellite imagery from Planet and Airbus provided a 'first look' at the fire impacted areas, and Nearmap aerial photography enabled a closer inspection of damaged areas. Also, vital was the government mapping data from VicMap, NSW Spatial Services and the NSW Royal Fire Service, which was used to aid interpretation.

The OpenStreetMap (OSM) Platform and Hot Tasker Manager were used to coordinate the mapping effort. NGIS Australia provided the technical support to create the SSSI Project Areas for the map-a-thon, which covered all the bushfire devasted areas. NGIS also worked with imagery and data providers to ensure all systems worked smoothly on the day. This was a significant piece of work and SSSI is grateful to NGIS for their leadership and generosity.





SSSI Young Professionals (YP's) were at the heart of the map-a-thon - from the lead up to the event, through-out the event and post event. YPs undertook OSM onboarding training, developed specific training materials, and coordinated map-a-thon training on the day.

The map-a-thon is one of the largest single event map-a-thons held in the Australasian region; with a total of 2,793,879 hectares were mapped, with 15,731 edits, 13,891 building edits, 1,091 damaged features mapped and 945 damaged buildings mapped.

This significant achievement has demonstrated that the combined talents of surveying and spatial community, SSSI volunteers and the OpenStreetMap Community can make huge inroads in improving the OpenStreetMap as an Australian community resource. These maps are essential for understanding where things, and navigating from A to B.

The map-a-thon and follow-on activities have highlighted that surveying and spatial science has an important contributing role to the safety and well-being of Australians by providing national mapping support for disaster preparedness and recovery efforts on a volunteer basis.

These efforts demonstrate that the surveying and spatial professionals can come together quickly as a formidable group for nationally coordinated volunteer mapping services.

10.3 Engagement

For SSSI to be an inclusive body that represents the surveying and spatial sectors, we cannot do this in isolation. MoU's are critical in fostering stronger collaboration in our region and beyond, as well maintaining our sustained relevance and opening opportunities for improved learning and knowledge sharing. Over the past 12 months, SSSI has signed MoU's with the following organisations:

Open Geospatial Consortium (OGC)	OGC is a not-for-profit international standards organisation dedicated to convening an ongoing forum to advance interoperability among IT systems that process geo-referenced information. The focus on the MoU is to collaborate on workshops, seminars, and the provision of Continuous Professional Development accreditation.
Association of Southeast Asian Nations Federation of Land Surveying and Geomatics (ASEAN FLAG)	ASEAN FLAG is a non-profit organisation that strives to promote and advance the science, practice and application of land surveying and geomatics, and to foster regional, national and international cooperation and transfer of technology. This MoU aims to foster stronger collaboration of surveying and spatial professionals in the region.
Pacific Geospatial and Surveying Council (PGSC)	PGSC is the regional body that represents the geospatial and surveying authorities of Pacific Island Countries and Territories (PICTs). The MoU will facilitate coordination, communication and collaboration and the sharing of resources and applications of location information to advance and promote the surveying and geospatial science industries.
URISA International Exchange Program	The SSSI Spatial Information & Cartography Commission has a longstanding international exchange program with Urban and Regional Information Systems Association (URISA). The 2019 delegates were Teresa Townsend, URISA past president (who visited Locate19 in Melbourne) and Kerry Smyth (former SICC Chair who visited GIS-Pro in New Orleans)
	As background, the SSSI relationship with URISA and GISCI was adopted 10+ years ago, and is formalised in two MoUs that cover: sharing of CPD programs; alignment of certification programs; sharing of objectives and values; and the exchange program.
	Exchange delegate Kerry Smyth reported a very successful and enjoyable visit to New Orleans, and is enthusiastic to progress the many actions that were initiated, most significantly sharing the GISCI online portal for GISP-AP Certification lodgements. Unfortunately COVID-19 has stalled further discussions, but engagement will continue in early 2021.

10.4 South East Asia Survey Congress, Darwin

SSSI was proud to be part of the South East Asia Survey Congress held in Darwin from the 15-18 August 2019. This is the first time in 20 years that Australia has hosted a joint international congress with the ASEAN Flag Surveying nations. The Congresses theme was Collaboration, Communication, Capacity Building in the 21st Century.

This event saw just over 400 surveying professionals from all over Australian and South East Asia convene for a dynamic four-day program.




10.7 Migration Skills Assessment

SSSI is the authorised assessing authority to assess qualifications and skills for the purpose of migration to Australia under the general skilled migration categories for the occupation of Surveyor ANZSCO 232212 ONLY (i.e. applicants must hold the equivalent of an Australian bachelor degree).
